DIRECTOR'S REPORT JANUARY, 2024

- **The new semester should start soon and I think I will hear from Mr. Vlakanc about the evaluation of library space when he knows how many students will be in the class. I believe this is only 1 credit so there may not be interest. I will let you know when I hear from him.
- **I still have not heard from the Girl Scouts concerning the playground. I think they still want to participate, but I am not sure why they are not contacting me about it? I think we should just go ahead and make decisions without them. I think we should be placing our order soon to get a spring delivery. The info I gave you a few months ago was a lot of paper, so if you still have them please bring them to the meeting. (I have one for Honroee)
- **I shared the estimate of the security cameras with Ken Reichman since he is does our IT work and will want to work with the installation project so he knows what is installed on the computers and how to access them. He feels that this estimate is a bit high compared to previous estimates. I thought it was, but wanted to check with Ken to see if he remembers. It may be a good thing to get another estimate before I start the grant process.
- **When Brian was here he talked a bit about having STLS take over the process of eRate. I do not think that was officially voted on, and it should be.
- **I have applied for and received the following grants: ARSL: Programming supplies for a series on Money (complete with tablets and all necessary supplies), not yet public, Allegany Area Foundation: Adult Craft Nights (so the \$900 budgeted can be used for programs outside of crafts), COSAC: Activities at the Senior Center. Marsha is working on an application for another firing workshop series. I have a couple more I am researching.
- **Allegany Library Directors are working on a joint program for the summer (Adventure Begins in your Library) program. Each participant would receive a "passport" they would go to the 17 libraries, do the event, get a stamp and at the end of the summer they would receive a prize. I have couple options I am looking into for Whitesville. This could be individuals, couples or families. Even groups, such as the Girl Scouts.
- **I am working on programs that involve items in our Library of Things as well as other programs for adults. Gay can you get me the information on the Lawn Yoga. If you have a program you would like me to plan please bring contact information and I will see what I can do.
